- Front-runner States; 10 in number, cumulative installed RE capacity more than 1000 MW. (Andhra Pradesh, Gujarat, Karnataka, Maharashtra, Madhya Pradesh, Punjab, Rajasthan, Telangana, Tamil Nadu, Uttar Pradesh)
- Emerging States: 8 in number, cumulative installed RE capacity less that 1000 MW but more than 100 MW. (Bihar, Chhattisgarh, Delhi, Haryana, Kerala, Odisha, West Bengal, Uttarakhand)
- Smaller States and UTs: All other, cumulative installed RE capacity less than 100 MW. (Andaman & Nicobar Islands, Arunachal Pradesh, Assam, Chandigarh, Dadar & Nagar Haveli, Daman & Diu, Goa, Himachal Pradesh, Jammu & Kashmir, Jharkhand, Lakshadweep, Manipur, Meghalaya, Mizoram, Nagaland, Puducherry, Sikkim and Tripura).

Applications are invited from the distribution companies, Solar and wind manufacturers, Project developers, Micro small and medium enterprises, Large Industries, Power producers, Microgrid developers, Innovative solution providers, integrators, financial institutions, project developers for ground-mounted and rooftop solar, biomass power generators, etc.

The awards will be announced in the conferences we will organize in the four regions of the country. We wish to invite international investors to the forum, wherein they can network with the performing energy companies, liaison with the ESCOs and financial companies to evaluate energy security for investments and EPCs.

I request your kind office to help us identify the organizations/Companies in your country, who are interested in exploring Indian Energy market and setting up JVs or invest in energy manufacturing projects. We wish to invite them in the conferences and facilitate business to business sessions with relevant Indian Companies and Government agencies for convergence.
